I. New Business

Allied Health

Practical Nursing

Gregg Allinson made a motion to add the prerequisite ***Admission in the BCCC Practical Nursing Program*** to NUR 101, NUR 102, and NUR 103 effective Summer 2010. Dixon Boyles seconded the motion. The motion carried.

Associate Degree Nursing

Gregg Allinson made a motion to add the prerequisite ***Admission in the BCCC Associate Degree Nursing Program*** to NUR 111, NUR 112, NUR 113, NUR 114, NUR 117, NUR 211, NUR 212, and NUR 213 effective Summer 2010. Donna Dunn seconded the motion. The motion carried.

II. Approval of Curriculum Committee February 2, 2010 Minutes

The February 2, 2010 minutes were distributed to all Curriculum Committee members. Chairman Beddard called for corrections to the minutes.

- The first item under Allied Health/Nursing is to delete *and NUR 111-Intro to Health Concepts* from the minutes. The minutes should read: Gregg Allinson made a motion to add a prerequisite of “Admission to the Practical Nursing Program” to NUR 101-Practical Nursing I effective Fall 2010. Dell Enecks seconded the motion. The motion carried.
- The second item under Allied Health/Nursing changed NUR 225 to NUR 255 (typo error).
- The fourth item under Allied Health/Nursing was corrected as stated. Gregg Allinson made a motion to include “or NUR 214” in the prerequisites for NUR 113 and NUR 212 effective Fall 2010.
