I. Old Business

The University of Mount Olive Articulation Agreement/Crosswalk was edited by UMO as requested. The changes were accepted by the committee, and the agreement was passed. The crosswalk goes into effect Fall 2015.

The Human Services Technology changes were split to make less substantive changes as requested by Senior Staff. The new HSE change packet was then reviewed by the Curriculum Committee. The HSE Curriculum Change was sent back for editing to clearly note the deletion of the HUM elective. The edited version was later approved via electronic vote on May 5, 2015. The changes will be effective Fall 2015.

II. New Business

The LPN curriculum change was a result of new mandates provided by the state board, which moves from system-based learning to concept-based learning. Changes were required in the catalog and the program of study. While the changes are mandated by the state for Fall 2016, it was explained that BCCC is trying to get ahead and implement the changes early. The changes were approved and will be effective Fall 2015.

To meet the new articulation agreement formed by the NCCCS, the N.C. university system, and the N.C. General Assembly requires changes to the ADN program. Changes to hours, courses, and prerequisites were submitted and approved by the committee. These changes will be effective Fall 2015.

Changes to the Welding program were submitted in order to provide students with specific skills they will need to work with specific employers. The change adds HYD-110 and removes WLD 212 and MEC 231. The changes were approved, and they will be effective Fall 2015.

A request to add courses to the Automotive program was noted to help students become more employable after finishing their coursework at BCCC. AUT-221 and AUT-221A was added to the diploma and the Career and College Promise programs. It was noted that the title for the change was incorrect, so the document was sent back for editing. It was approved by electronic vote on May 5, 2015. The changes will be effective Fall 2015.

It was brought to the attention of the board that there have been some issues with entering diplomas in Datatel at the state and local level because ENG 102 was included with some degrees as well as ENG 111. It was proposed that ENG 102 be removed and ENG 111 be used

for diplomas for associate's degrees. The committee agreed, and the change was approved for Fall 2015.

The programs of study for the associate's degrees in Arts, Science, and General Education were submitted for review. It was noted under the General Education description that ACA 122 and ENG 114 were not listed as options. The item was sent back for editing. The changes were made, and it was approved by electronic vote on May 5, 2015. These programs of study will be effective Fall 2015.
