Discussion then was held on the new firing range currently under construction. OSHA is developing standards for lead exposure for instructors. This will affect how many hours an instructor may be on the firing range. Lead-free ammunition is available. Bobby will develop a safety policy and procedures for the firing range. This will be in conjunction with personal protective equipment.

Safety around the range will need to be addressed. It was suggested that a fence, topped with barbed wire, be around the range and pond. Hal will develop a policy and submit for approval. There needs to be storage area in building #10 for students to leave their weapons while attending other classes on campus.

OSHA Training

Training will be available on: fire extinguishers, forklift training and bloodborne pathogens.

Hal requested updated sub-committee rosters be submitted to him.
